I have been working on a survey, for a year, to see who does not have Fiber Optic Internet, in Minerva. Due to Slic bids done by Census Block, some areas were not included in the bids. We have grants available. We have ARPA (American Rescue Plan Act) Grants of \$78,000.00 and \$24,000 from Essex County. It would all be covered. ARPA can be used for 4 different things, Our Town has the option to use it for Broadband or Water.

If we use it for this project we will have 99% broadband coverage in our town.

I am going up Wednesday to meet in the County, with Stacie McNally and Kathy Persons.

We have \$39,000 already. We should get the other \$39,000 any day now. So, we should be ready to go.

- The issue with the dump Truck running into McCall Property, we are still working on that.
