## Highway Superintendent's Report:

- Governor has added a new an Anagram to the CHIPS form this year. Now we have POP/Pave Our Potholes. Which is \$14,777, it can only be used for Paving. Can top coat on McKee and 14th. Might be a good year to buy a piece of equipment.
- Storm was Devastating. Clean up was Horrendous. Due to previous rain, 14<sup>th</sup> road h=was wiped out. Ditches and culverts need to be done right, for proper drainage, like North woods club road.
- Water main break: 1st water sample came back negative/clear. Took the 2nd sample down this morning. Need 2 clear samples to lift advisory.
- We spent a lot of money on sand and salt, about 2/3 to our total pile.
- Small Dump is out of commission. Code reader is not up to date. It is under warranty. May have to send Tucker to Plattsburg to have it checked out. Tucker is going to try one thing first, he thinks it's the Lift Pump.
- Would like to get a letter to Mark Nazigian at the Owl at Twilight. He is going to have to pay for his own water tap. He currently runs off JR Pratts tap. It would be around
