- Budget Forms are out, to the department heads, we have the preliminary numbers, I have an idea we will not be able to stay under the cap, due to the price of fuel, etc.

- Located a water leak in Corrine Coyle's service line that was significant and was losing about 10,000 gallons per day. Tucker's did that.

- I have asked John Bradway to come get the box of the white truck for scrap price.
- We have had guys using up vacations up this past month.
- I would like to ask that we consider putting a single line across the road, by Hayes/Barnes, so we don't have to get a permit to dig the road in the future, in anticipation for development on those lots.
