### **CAMPGROUND RULES 2023**

## **CAMPING**

- Campers under 18 years old must be accompanied and supervised by the permit holder.
- You may not sublet your campsite to someone else. Everyone staying in the site must be listed on the registration form. A registered guest MAY NOT be the primary user of your campsite.
- You (the permit holder) are responsible for the conduct of everyone on your site. You are liable for any violations.
- One family (four adults and no more than eight people) per site.
- You may occupy and place equipment only on your assigned campsite. One approved camper or tent per site. In addition, one portable screen house <u>or</u> 4-person tent is allowed, used in conjunction with one platform not exceeding 10 feet by 12 feet. NO other structures of any type are permitted.
- You may arrive to your site after 12PM on your reservation date.
- You must leave your campsite no later than 11AM on the final day of your stay.
- Garbage disposal is your responsibility. You may use your camping permit to dispose of most types of garbage at the Minerva Transfer Station. RECYCLING is required.
- Upon registering you allow the approval of random checks of campers through the National Sex offender registry.

## **GENERAL BEHAVIOR**

- Quiet hours: 10:00PM to 7:00AM.
- Generators may be used between the hours of 8:00AM-10:00AM and from 4:00PM-7:00PM.
- Campground speed limit is 5 MPH.
- NO unregistered vehicles allowed.
- Do not deface or remove signs, structures, or barriers.
- Do not remove or injure any plants, trees, flowers or rocks.
- NO firearms or fireworks.
- Do NOT post signs or notices.
- NO fighting or violent or threatening behavior.
- Do NOT obstruct vehicular or pedestrian traffic.
- Water hoses may be connected to the water outlets for the purpose of filling water holding tanks but must be disconnected and picked up when not in use.
- NO running of extension cords allowed to Town outlets.
- For the safety of others, All-Terrain Vehicles (ATVs), Utility Terrain Vehicle (UTVs), Mobile Scooters, and Golf Carts are not allowed on the campgrounds during the camping season, unless the Town is provided with a reason for necessity and it is approved.

#### **CAMPFIRES**

- Do not leave fire unattended! Please rake needles away from pit. NO chainsaws.
- Build all fires in the fireplaces provided for that purpose.
- Fires permitted for cooking and warmth ONLY. Firewood can be gathered on site from dead and down trees ONLY. All firewood burned at Donnelly Beach must be harvested from trees grown within 50 miles of the Town of Minerya.

### **CAMPGROUND RULES 2023**

## **ALCOHOL**

- NO person under 21 years of age shall possess or consume alcoholic beverages.
- Persons age 21 or older who possess or consume alcoholic beverages must produce adequate identifications and proof of age upon request.

### **SWIMMING AND BEACHES**

- Swim at the beach only when lifeguards are on duty.
- Change your clothes only in fully enclosed tents, trailers or in the bathhouses.
- NO alcoholic beverages or glass containers on the beach.
- NO smoking on the beach.

#### **PETS**

- You must register and provide proof of valid rabies inoculation or current dog license for your pet.
- NO dogs or other pets on the beach.
- Confine or leash pets to restrict them to the campsite of the owner.
- Dogs may be walked on a leash no longer than 6 feet, provided they are under control at all times.
- Dispose of your pet's excrement.
- Do not leave your dog unattended.
- Barking or vicious dogs must be removed from the campground immediately upon request from any Town of Minerva Staff.

## INSTRUCTIONS FROM TOWN EMPLOYEES

- Please comply with the lawful instructions of a Town Employee.
- Do not prevent employees from performing their duties by intimidation, physical force or interference.

### VIOLATIONS

- The Town of Minerva reserves the right to deny any camping permit based on past behaviors or violations. Violating campground rules may result in your eviction. If we ask you to leave, you will need to vacate your campsite and remove all of your equipment immediately.
- Refunds will not be given to evicted campers.
- If your camping permit expires and you still are occupying the site but cannot be located, you will pay a campground handling charge in the amount of \$45.00 and the Town may remove your personal property. Any tent or other camping equipment left unoccupied from more than 48 hours may be taken down and removed.
- Moving a camper into the site before the date noted on your camping permit will result in a \$35.00 per day charge in addition to the regular camping rate.

## **CANCELLATION POLICY**

- You may request a refund, minus processing charges, by calling the office and submitting a written request, 7 days prior to your check in date.
- Requests for refunds within 7 days of your check in date will be presented to the Town Board for consideration.
- Refunds will not be issued for poor weather conditions unless the campground is closed due to extreme weather.
