Application Process for the Zoning Board of Appeals (ZBA)

- The ZBA meets on the second Tuesday of each month.
- All application materials must be submitted by the <u>first Wednesday of the month</u> for consideration at the next regularly scheduled meeting.
 - o If there is no business by the first Wednesday of the month, the ZBA reserves the right to cancel the meeting for that month.
- Applications/materials received after the first Wednesday of the month will not be considered until the following month.
- Applications/materials should be submitted as one complete submission, by the first Wednesday of the month, rather than submitting various parts at a time.
- Initial applications and materials shall be submitted directly to the Town Hall along with the accompanying fee, either in-person or by mail to:

then the application will need to be submitted by the Minerva ZBA to the Essex County Planning Board for review PRIOR to the Minerva ZBA making any determination on the application.
