Supervisor's Report:

- Spoke with DEC about proposing an ordinance that would prohibit fishing at Minerva Lake until later in the season, to provide the fish a break and reduce trauma to the pike. Last year the lake was over fished early in the season. Enforcement will be through signage.
- Received a call from the insurance company, they are requiring that the town's highway trucks install battery disconnects on all large trucks. The estimated cost for this installation is around \$2,500 to \$3,000 per truck. If not completed, it will limit insurance coverage on the trucks and buildings.
- The resource center is being visited more frequently thanks to the volunteers who are monitoring it and offering open hours.
- There will be a gathering at the monument honoring veterans on Monday at 11:00 AM. -
- The warming hut has been equipped with rubber mats and benches for the ice skating season, made possible by a grant from the Adirondack Foundation Community Fund for the Gore Mountain Region (CFGMR).
- We need to consider a stainless steel wash sink for the warming hut..
